UPDATE FROM ELECTED OFFICIALS:

Pat Outman gave an update of what is happening in the Michigan House

- Ford Economic Deal Huge price to fund a EV battery plant in Marshall. Ford is partnering with a Chinese company to open/run the plant.
- Gun restricting going through Judiciary. GOP trying to push back with reasonable amendments.
- Motion passed that repealed the 1931 abortion ban in Michigan GOP offered reasonable amendments that were voted down.
- Expansion to the Elliott-Larsen Civil Rights legislation.

Rick Outman gave an update on what is happening in the Michigan Senate.

- Delay in the Pension Bill
- Not currently using committees to discuss the proposed changes in legislation.
- Income tax roll back, baked into revenue.
